Chairman Seminary called the special meeting to order at 2:30 P.M. Roll call was taken, and a quorum was present by Teams.

#### LEGISLATION

Ms. Fricke provided information about additional bills introduced since the January 7<sup>th</sup> board meeting that could impact NDPERS.

Ms. Audra Ferguson and Mr. Robert Gauss, legal consultants with Ice Miller, were present by phone to provide a federal law compliance analysis of Bill Draft 1187. As written, Bill Draft 1187 creates an impermissible cash or deferred arrangement ("CODA") creating a plan qualification concern with federal law.

House Bill 1248, Section 2 removes the Employee Benefits Programs Committee's jurisdiction, and thus process, bill proposals that fiscally impact the health insurance and retiree health plans of state employees or employees of any political subdivision. As written, Section 2 of the bill would remove the ability to provide thorough, independent cost and technical analysis on these proposals through the use of our actuary and consultant. HB 1248 also repeals the insurance mandate requirement under Section 3. Two amendments are being prepared. The first is to remove Section 2 from the bill so that the current law remains related to jurisdiction of the Employee Benefits Programs Committee. The second amendment is being drafted to remove language that places this responsibility of the NDPERS Board to submit a bill proposal at the end of the NDPERS pilot program to roll the coverage out to the commercial market regulated by the Insurance Department..

Senate Bill 2180 requires several changes for public meetings, including a required public comment period at public meetings.

Senate Bill 2215 restricts executive branch agencies from submitting a legislative bill for introduction unless legislative management or a committee of the legislative management requested the agency to submit the bill.

Discussion followed.
