Sanford Health Plan (SHP) Well-being Education Presentations

Ms. Rebecca Fricke introduced the staff from Sanford Health Plan. Ms. Rachel Iverson began the presentation with an overview of the many well-being online training sessions that SHP provides. She discussed several topics such as *Healthy Meals in a Hurry* and *Mindful Eating, Love Your Job*, and *Overcoming Stress*. She shared techniques to mitigate stress and how to find a technique that works for you. Ms. Iverson introduced new training topics: working from home that works, exercise without perfection, and nutrition and hydration.

Ms. Audra Janke reviewed a snapshot of a lengthier training entitled *Financial Flourishing – Growing Your Financial Well-being* that is available to health plan participants.

Actuarial Assumed Rate of Return Analysis

Mr. Scott Miller provided background regarding past changes to the assumed rate of return for the retirement plans. Mr. Miller introduced Ms. Bonnie Wurst from Gabriel Roeder Smith (GRS). GRS is an actuarial consulting firm under contract with NDPERS, not an investment firm. Ms. Wurst presented the detailed July 1, 2022 analysis of the assumed rates for all the NDPERS plans, and the recommended changes. Discussion followed.
