Chairperson Mona Rindy called the meeting to order at 8:30 A.M. Roll call was taken, and a quorum was present.

Mr. Scott Miller introduced the new appointee of the Attorney General, Ms. Claire Ness. Ms. Ness shared information about herself and her work history.

Chairperson Rindy called for questions or comments regarding the minutes of April 12, 2022.

## **PRESENTATIONS**

#### Health Plan Executive Summary 2021 Quarter 4

Mr. Steve Webster reviewed the annual membership and membership trend. The Board discussed NDFIT and the draw of political subdivisions to NDFIT. Steve provided background information about the organization and explained that the state of North Dakota is divided into eight regions. It began with schools, then included public entities. NDFIT moved to offer a self-funded product in that trust. Small entities can afford to be self-insured if they purchase stop loss for risk. Brown and Brown administer the trust for NDFIT.

Steve continued with a review of claims analysis and membership and utilization. Costs related to a COVID diagnosis were lower in 2021 compared to 2020. The cases are less severe with lesser critical care required. With the lower severity of COVID, patients improve more rapidly with shorter hospitalization. Vaccinations are a contributing factor to the change in COVID costs. Three percent of the pharmacy utilization for NDPERS was the COVID vaccine.

Mr. Danny Weiss stated that cancer has consistently been the largest claims group at nearly 30 percent of claims followed by heart/circulatory at just over 17%. There is little cost management with a cancer diagnosis.

Mr. Weiss discussed the generic utilization of prescription drugs. He gave examples of the impact of advertising on patient demand for a brand-name drug. Humira biosimilars are coming to market in 2023, and as a result, advertising has disappeared for Humira. To keep the market share, Rinvoq is being promoted instead.

Mr. Webster reviewed the Lifestyle Medicine Programs and stated that the programs are effective and have good outcomes. Wellness program attendance and engagement saw an increase during Quarter 4 of 2021. There are concerns with 4 areas in the Performance Standards and Guarantees.

# Draft Health Plan Request for Proposal

Mr. Derrick Hohbein presented a proposed timeline and draft Request for Proposal in the event the Board goes out to bid for the Group Health Plan later this year. The topic was for information only.

#### Contract Amendment for Dental Plan

Ms. Rebecca Fricke recapped the discussion from the March meeting when the Board approved the contract renewal with Delta Dental for the group dental plan. Ms. Fricke presented the contract amendment for the January 1, 2023, through December 31, 2024 contract period. The amendment was drafted by legal counsel and approved by Delta Dental.

# Medicare Part D Plan 2023 Premium Projection

Ms. Fricke reported that Humana provided a preliminary projection for the 2023 premium for the Medicare Part D Plan. The projected premium of \$69.72 per month is lower than the premium that was guaranteed as a premium cap in the 2021 bid process.

Humana will finalize the premium for the upcoming plan year after the Centers for Medicare and Medicaid Services (CMS) releases the federal subsidy level for Part D plans in the latter part of July. After Humana determines whether they need to adjust premiums based on the subsidy amount and the experience of the plan, Humana will provide the final premium for the Board's consideration.

If the final renewal premium exceeds the projected premium and the Board does not wish to renew, a final Medicare Part D RFP will be prepared for the August Board meeting for approval and an immediate release. Discussion followed.

#### **Board Election Update**

Ms. Aime Miller provided an updated timeline for the board election.

#### Budget

Mr. Derrick Hohbein summarized Governor Burgum's budget guidelines for the 2023-25 biennium and the agency appropriation authority for the current biennium. He recapped the discussion from the November 2021 Board Planning Meeting regarding several initiatives with budget implications. The Board discussed staffing and a request for three full-time equivalent (FTE) staff, an equity package for the classified staff and the Executive Director, a one-time funding request to continue the additional Sagitec Developer for the PERSLink Business System, and staffing considerations in the event the Defined Benefit Plan is closed or the Health Insurance Plan and/or pharmacy benefits become self-funded.

For the remainder of the 2021-2023 budget, staff currently do not anticipate the need to transfer any other contingency funds unless there are unforeseen initiatives, retirements, or mandates over the next year.

It was the consensus of the Board for the Executive Director Performance Review and Compensation Committee to work on an equity package for both the Executive Director and classified staff.

The Board also discussed funding for a review of the Internal Audit Division which would include a self-evaluation and an external peer review. This item will be added to the continued budget discussion at the June Board Meeting.

# **HR Policy Manual**

Mr. Scott Miller presented three proposed revisions to the HR Policy Manual that warrant a timely update. Staff will complete a full review at a later date. The Board discussed updates to Chapter 2.8 Dress Policy, Chapter 18.7 Education and Training, and Chapter 22 Disciplinary Procedures.
