## SUBJECT: HEALTH INSURANCE PREMIUM RATE CHANGE

The monthly health insurance premium rates for state employees will change for the 2025-2027 biennium.

Employers who participate in the Wellness Program will be assessed the A rate and those who do not participate in the Wellness Program will be assessed the B rate.

The new rates will be effective July 1, 2025 through June 30, 2027:
