Subject:	State Public Safety Plan – Expanded Eligibility and Upcoming Employer Contribution Changes

## EXPANDED ELIGIBILITY

Four bills, passed during the 69<sup>th</sup> Legislative Assembly, expand the eligibility into the NDPERS State Public Safety Plan to the following groups effective August 1, 2025:

- HB 1112: Expands eligibility to include *state* firefighters
- HB 1177: Revises the definition of 'correctional officer' to include those employed by a correctional facility who are *enrolled in a correctional officer course, but not yet certified, as a correctional officer*
- HB 1274: Expands eligibility to include *state* correctional officers
- HB 1419: Revises the definition of 'correctional officer' and expands eligibility to include *state dispatchers* as well as *political subdivision dispatchers and emergency medical services personnel*

# UPCOMING EMPLOYER CONTRIBUTION CHANGES FOR STATE PUBLIC SAFETY PLAN

In alignment with NDPERS Board action and recently passed legislation, the State Public Safety employer retirement contribution will increase this year for payroll reports beginning in August and again in January 2026. The National Guard and BCI employer

retirement contribution will also increase on January 1, 2026. These employer-paid contribution rates will automatically update for Central Payroll.

**STATE PUBLIC SAFETY RETIREMENT PLAN EMPLOYER CONTRIBUTION RATES** For state peace officers, and effective August 1, 2025, includes state firefighters, state correctional officers, and state radio dispatchers.
