## 1 II. TIME OF DISTRIBUTION TO ALTERNATE PAYEE

2 Upon acceptance of this order as a Qualified Domestic Relations Order by the North Dakota Public 3 Employees Retirement System Board of Trustees, the amount awarded to the alternate payee 4 shall be transferred into a separate bookkeeping account on behalf of the alternate payee. 5 Alternate payee shall be entitled to any earnings or losses accruing on the alternate payee's share 6 from the date of divorce to the date of the transfer of funds by the Plan to the alternate payee's 7 account.. Distribution of the alternate payee's account balance may begin at any time after the 8 transfer of the alternate payee's funds into the alternate payee's account, and must be made as a 9 lump sum lpayment within one hundred twenty days (120) of the later of the board's acceptance of 10 the Qualified Domestic Relation s Order or the entry of the Order by the Court. However, any 11 distribution will be subject to any restrictions imposed on the Participating member's account. 12 III. LIMITATIONS OF THIS ORDER 13 14 (Note: Order must reflect all provisions of this section.) 15 Α. This order recognizes the existence of the right of the alternate payee to receive all 16 or a portion of the benefits payable to the participating member as indicated above. 17 Β. Nothing contained in this Order shall be construed to require any Plan or Plan 18 administrator: 1. 19 To provide to the alternate payee any type or form of benefit or any option 20 not otherwise available to the participating member under the Plan. 2. To provide the alternate payee benefits, as determined on the basis of 21 22 actuarial value, not available to the participating member. 23 3. To pay any amounts to the alternate payee that are required to be paid to 24 another alternate payee under another order previously determined by the 25 Plan administrator to be a qualified domestic relations order. 26

- C. 2 If the participant or alternate payee receive any distribution that should not have been paid per this order, the participant or alternate payee is designated a 3 4 constructive trustee for the amount received and shall immediately notify NDPERS 5 and comply with written instructions as to the distribution of the amount received. 6 7 D. Alternate payee is ORDERED to report any payments received on any applicable income tax return in accordance with Internal Revenue Code provisions or 8 9 regulations in effect at the time any payments are issued by NDPERS. The 10 investment provider is authorized to issue Form 1099R, or other applicable form on 11 any direct payment made to alternate payee. Plan participant and alternate payee must comply with the Internal Revenue Code and any applicable regulations. 12 E. Alternate payee is ORDERED to provide the Plan prompt written notification of any 13 14 changes in Alternate Payee's mailing address. NDPERS shall not be liable for any 15 failure to make payments to alternate payee if NDPERS does not have a current 16 mailing address for alternate pay. 17 F. Alternate payee shall furnish a certified copy of this Order to NDPERS. 18 G. Subject to the provisions of the IRC Sec. 457 (b) and the Plan, if the alternate 19 payee dies before receiving distribution of the entire amount contained within the 20 alternate payee's account, the alternate payee's remaining account balance shall 21 be paid to the alternate payee's designated beneficiary or, if none, to the alternate 22 payee's estate. Alternate payee may designate a beneficiary by filing a beneficiary 23 designation with the investment provider. 24 25

- 1H.If the participant dies any time after this Order or an amended version of this Order2is accepted by NDPERS as constituting a Qualified Domestic Relations Order, the3alternate payee's benefits under the plan shall not be affected.
- I. By consenting to this Order, the participant agrees that the Plan, the Plan Trustees,
  NDPERS and any investment provider to the plan are hereby released from any
  further claim by participant with respect to the benefits set aside in this Order for the
  alternate payee.
- 8J.By consenting to this order, the alternate payee agrees that any payments made to9the alternate payee shall be reduced by the required income tax withholding.10Alternate payee hereby releases the Plan, the Plan Trustees, and NDPERS from11any further claim with respect to that amount of money withheld for income tax12purposes from the benefits set aside for the alternate payee.
- K. By consenting to this order, the alternate payee affirms the alternate payee's 13 14 understanding that the alternate payee will be responsible to direct the investment 15 of the alternate payee's fund balance and that the alternate payee is solely 16 responsible for the investment results of the alternate payee's fund balance. The 17 alternate payee hereby releases the Plan, the Plan Trustees, NDPERS, and the 18 investment provider from any liability or further claim for any election or investment 19 decision the alternate payee makes based on information provided to the alternate 20 payee pursuant to N.D.C.C. chapter § 54-52.2-03.3.

7		alternate payee by this Order and so notifies the parties, either or both parties shall
8		immediately petition the Court for reformation of the Order.
